This is a summary of the Annual Report for the United Steelworkers Local 286 Severance/401(k) Trust Fund, Employer Identification Number 23-2059315 Plan No. 002 for the year ended December 31, 2015. This Annual Report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Benefits under the plan are provided by a trust fund and are funded with contributions to the Fund by contributing employers, participants, and by investment earnings.

BASIC FINANCIAL STATEMENTS

The value of plan assets, after subtracting liabilities of the plan, was \$22,543,091 as of December 31, 2015 compared to \$21,891,680 as of January 1, 2015. During the plan year, the plan experienced an increase in its net assets of \$651,411. This increase includes unrealized appreciation or depreciation in the value of the plan's assets; that is, the difference between the value of the plan's assets at the end of the year and the value of assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$2,681,824 including employer contributions of \$2,115,111, employee contributions of \$525,153, losses from investments of (\$24,042) and other income of \$65,602.

Plan expenses were \$2,030,413. These expenses included \$453,265 in administrative expenses and \$1,577,148 in benefits paid to participants and beneficiaries. A total of 2,936 persons were participants in or beneficiaries of the plan at the end of the plan year.
